BC Wine Appellation Task Group "Plebiscite Campaign"

Executive Summary

On February 1st a project was begun to communicate the work of the BC Wine Appellation Task Group ("Task Group"); to respond to questions among wine industry stakeholders; and to promote awareness of the plebiscite vote on Task Group's recommendations for regulatory reform.

The project was spearheaded by Mike Klassen in cooperation with Task Group chair Ezra Cipes, with advisement by the BC Wine Institute and the BC Wine Authority. It facilitated the work through a combination of group presentations, one-on-one discussions, social media engagement, email communication, media relations, and video all to raise industry awareness of the recommendations and the pending vote.

When one of the Task Group's original recommendations failed to win the approval of several prominent industry stakeholders, it was decided to revise the original recommendations, then to re-assemble the Task Group to discuss and vote on the changes. The group met by teleconference in mid-April and unanimously approved the final set of recommendations, which were then presented to the BC Wine Authority.

After preparing the ballot questions, the wine industry plebiscite vote began on May 20th and concluded on July 1st. The vote turnout for BC Wine Authority members was 78 percent, and 56 percent for non-members, representing 93 percent of wine production volume in British Columbia.

Feedback from industry stakeholders has been extremely positive on the effort placed on reaching out to stakeholders. In terms of voter turnout, we have achieved expectations.

An official result of the plebiscite vote tabulated by the BCWA was released to the public on July 8^{th} .
